- I. Title: Introduction to Probability and Statistics
- II. Catalog Description and Prerequisite(s): Elementary probability, the binomial, normal, student's and chisquare distributions, random sampling, regression and correlation.
 Prerequisite(s): ACT math standard score of at least 20 or MAT 097.

III. Course Objectives: The student will

A) Have the tools that will enable them to understand and appreciate the role probability and statistics plays in the process of gathering data and drawing information from it;

B) Understand experimental design, random sampling and sampling variability;

C) Learn and implement strategies for summarizing and displaying data in ways that aid the investigator in drawing conclusions;

D) Be able to apply concepts like measures of central tendency, dispersion and correlation will be applied to a variety of examples from different discipline;

E) Understand the role of probability in quantifying the uncertainty in the decision process will be emphasized;

F) Learn elementary probability concepts through problem solving;

G) Be able to use probability distributions like the binomial and normal distributions in the context of applications where they are the appropriate tools for analysis;

H) Understand the role of formal inference procedures such as confidence intervals and hypothesis testing as general strategies for making decisions;

I) Understand and be able to implemen these strategies in a few common settings (e.g. the t-test for a mean).

IV. Content Outline: We will discuss portions of chapters 1-23, and other chapters if time permits from the assigned book. The topics covered

A) Have the tools that will enable them to understand and appreciate the role probability and statistics plays in the process of gathering data and drawing information from it;

B) Describing and summarizing data (Graphical and Numerical)

C) Relationships in data (Correlation, Linear regression, least squares principle, categorical data, contingency tables)

D) Producing data (Experimental design, randomization, Sampling, random samples, simulation, sampling variability, bias)

E) Probability concepts (Random variables and probability distributions, Binomial distributions, Normal distributions, sampling distributions

F) Inference (Confidence intervals, Hypothesis testing-general strategy, Applications [one sample-means and proportions, two sample-means and proportions]

V. Instructional Activities: The first part of most classes will be spent going over questions from the homework assigned in the previous class. The next part of class will be spent lecturing over any new material. On occasion time will be given for the class to work in groups on problems.

VI. Field, Clinical, and/or Laboratory Experiences: None.

VII. Text(s) and Resources: Intro Stats, by De Veaux, Velleman, and Bock; Addison Wesley; Along with the text and a graphing calculator, the video series Against All Odds: Inside Statistics (26 half-hour programs), produced by the Consortium for Mathematics and It's Applications, is available for use in the classroom and/or by students outside the classroom. A graphing calculator is required for portions of this course and will be necessary for exams. The TI-83 and TI-84 are preferred, since they have a statistical package which will be used in the course. The TI-80, TI-81, TI-89, and TI-92 are not allowed.

VIII. Evaluation and Grading Procedures:

The final grade will be determined by adding together attendance bonus points, class points (group work, homework, and any projects) worth 100 points, three test grades each worth 100 points, and the final exam worth 100 points. This total is the final semester points. The final grade is then determined by dividing the semester points by 5.

Grading Scale: A = 90 or above, B = 80-89, C = 70-79, D = 60-69, and E = 59 or below.

Class Points:

- Homework assignments will be done online at <u>www.mathxl.com</u>. Homework will count for 50% of the Class Points.
- Throughout the semester Group Work will be assigned to be done in class. Group Works will count 50% of the Class Points. There is no makeup for Group Works. At least 10% of the total Group Work points will be dropped when figuring the Group Work Grade to take into account missing for legitimate excuses.

Tests: There will be 3 tests each worth 100 points. They are tentatively scheduled for **February 6th**, **March 5th**, **and April 8th**. If a test is missed for a reasonable excuse, it is the student's responsibility to contact the instructor **within 1 day** of the exam. Otherwise, the test grade will be 0. If arrangements for a makeup cannot be made in a timely fashion the final will count as the test grade in addition to counting as the final.

Final: The final exam is part **cumulative** and part material since the third test. It will be from **1:30 pm to 3:30 pm on Thursday, May 8th.**

Grade Change Option: A student has the option to replace their lowest test grade with the average of the original test grade and the final. This will only be applied if it helps the grade.

Auditing: The student MUST have the permission and signature of the instructor to audit or change to audit the course. An auditor MUST continue to do all the graded assignments, to attend classes regularly after the audit is given, to miss no more than 5 class periods after the audit is given, and to maintain at least a 40% average in the course. If these requirements are not followed, then an "E" will be earned for this course.

IX. Attendance Policy:
