



## Girl/Adult Financial Assistance

GSK is committed to providing a positive experience to every girl who wants to be a Girl Scout. No Girl Scout will be left behind. Financial assistance is provided so that a family's economic status will not be a barrier to any girl's ability to participate in Girl Scouting.

In general, families should be prepared to pay what portion they can for membership & registration fees. Any outstanding portion of the fee can then be covered through other means, which includes cookie dough and financial assistance from the council. Troops are highly encouraged to utilize profits from product sale programs and other troop funds to budget for membership & registration fees throughout the year. Setting budgets and managing troop funds is a part of the Girl Scout Leadership Experience.

### Membership Fee

For girls, the membership fee is \$30.00 (\$15.00 Girl Scouts of Kentuckiana service fee & \$15.00 GSUSA membership fee). Those girls/adults requesting membership financial assistance may not register electronically via e-biz. Financial assistance is available on a very limited basis to volunteers. It will be limited to those volunteers that hold a troop leadership position (01, 02, troop cookie volunteer) and on a case-by-case basis. The membership registration form and the request for Financial Assistance Application must be turned in together for processing.

### Girl Programs

Girls may apply for financial assistance for a specific program. A copy of the program description, including the detailed fee description, should be attached.

### Day Camp / Camporees

Girls may apply for financial assistance to attend a day camp or camporee. The camp name should be listed on the application form. There is a separate form that should be utilized for resident camp.

### Volunteer Training Session

Volunteers may apply for financial assistance to attend a training session that enhances or expands their knowledge for their position.
